

Library Technical Assistant 2- Circulation Department and Technology Assistance (Part-Time)

The E.C. Scranton Memorial Library in Madison, CT seeks a customer service oriented, collaborative and flexible individual to join our team. This person must be able to provide one-to-one technology assistance to library patrons by appointment. Additionally, the position includes circulation of books and other materials, which is one of the Library's most important functions. Circulation staff members play a key role in library services by providing prompt, accurate, and friendly service. The successful candidate for this position will have strong computer and technology skills; excellent oral and written communication and interpersonal skills; and the ability to provide excellent customer service to patrons of all ages.

Essential Job Functions:

- Provide appointment-based technology assistance to library patrons for their personal devices (7.5 hours/wk.)
- Assist patrons in the use of library technology and digital media
- Participate on the Library Technology Committee
- Check in and check out materials
- Register new patrons and provide orientation information
- Find and process holds and notify patrons when they are available
- Assist patrons in person and over the phone
- Perform other Circulation activities as assigned
- Help cover Children's Desk as needed

Qualifications:

- High school diploma or GED (college preferred)
- Computer skills, including keyboarding; basic knowledge of MS Word and Excel; familiarity with the Library's online catalog, website, databases, and other electronic resources
- Ability to train and coach patrons in the use of technology software and devices
- Capacity to perform detailed work consistently and accurately
- Ability to deal pleasantly and effectively with the public, including upset patrons
- Experience with IT Help Desk support, a plus
- Experience with III Sierra ILS, a plus

Physical Demands:

The physical demands described here are representative of those that must be met by an employee to successfully perform the essential functions of this position. Reasonable accommodation may be made to enable individuals with disabilities to perform the essential functions.

- Duties require moving throughout the building to access collections, lead programs and meetings, and operate office equipment.
- Duties require ability to express and exchange ideas by means of the spoken word and to perceive the nature of sounds at normal speaking levels, with or without correction.
- Duties require close visual acuity for extensive reading and viewing a computer terminal.
- Duties require extended periods of standing, walking, and sitting.
- Duties require occasional periods of pulling/pushing items, lifting/carrying items up to twenty pounds, bending, stooping, and fine manipulation skills.

A base of 23 hours per week including Wednesday evenings and every other Saturday for a weekly average of 26.5 hours.
